### PRESIDENT'S COLUMN

I sometimes wonder who was the marketing guru that proposed use of the term "disposable" for certain plastic objects. It is a gross misnomer. We, or at least our bodies, are more "disposable" than plastic, in the sense that, if not preserved, we will return most of the borrowed molecules that constitute us for reuse soon after we pass.

Don't get me wrong. Plastics are amazing materials. Since the first report of a man-made plastic in 1862 and of man-made polymers in 1920, scientific research has yielded a remarkable range of polymeric materials. Given the many beneficial properties of, for example, polyethylene, polypropylene and polystyrene, it is hard to consider how such materials might be replaced in many of their applications, even though they are relatively recent inventions. And natural polymers, albeit biodegradable, namely proteins (polypeptides), polysaccharides and polynucleic acids (such as DNA and RNA), constitute much of the fabric of our own bodies.

Plastic objects are labelled "disposable" because they are cheap. But does the price I pay now for a single-use plastic item properly reflect the cost to the rest of our neighbors globally, to say nothing of the cost to future generations or to the other beings with which we share the planet? ## **Miramar Recycling Center**

The following information is from the Miramar Recycling Center website,

https://www.sandiego.gov/environmental-services/recycling/centers/miramarrecycle:

The Miramar Recycling Center is located north of state Route 52 at 5165 Convoy St. in San Diego. Business hours are Monday through Saturday from 7 a.m. to 4:30 p.m.

The Recycling Center is CLOSED on the following holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.

**IMPORTANT INFORMATION**: In response to COVID-19 directives, the City is limiting the number of customers allowed into the recycling center to accommodate social distancing. As a result, delays may occur.

The Miramar Recycling Center serves as a drop-off center for many recyclable materials. This includes large or bulky items that can be recycled but cannot go in either the black trash bin or the blue recycling bin. Operated by Allan Co. Recycling, the center accepts four classes of recyclables:

- 1. refunds for recycling: materials with refund and scrap value;
- 2. "donation only" items;
- 3. recycling fees for items banned from disposal in your trash or in the landfill (handling fee charged); and
- 4. recycling fees for miscellaneous recyclables not accepted in the City's curbside recycling program (handling fees charged).

#### **Refunds for Recycling**

The Miramar Recycling Center pays a California Redemption Value (CRV) refund for all aluminum, plastic, glass and steel beverage containers for which a CRV deposit was charged. Scrap value is paid for some types of metals, newspaper and cardboard (call for pricing).

#### "Donation Only" Items

Some recyclables that do not have refund or scrap value are accepted for donation (no payment or fee charged to the customer). "Donation only" items include:

- TVs, computer monitors and computer processing units(CPUs);
- non-CRV glass bottles and jars (clear, blue, brown and green);
- non CRV and narrow neck plastic containers;
- non-CRV steel cans;
- metals ferrous (iron) metals like barbecues, wrought iron, etc.;
- mixed paper; and
- used residential cooking oil maximum 30 quarts.

### **Recycling Fees**

- 1. The Miramar Recycling Center accepts (for a fee) the following items which are prohibited by local and California State law from trash disposal:
  - refrigerators, freezers, air conditioners and other appliances that contain chlorofluorocarbons (CFCs); Fees (all customers) \$25.00 each
  - large household appliances (stoves, washers and dryers, hot water heaters, etc.); Fees (all customers) \$12.00 each
- 2. The following miscellaneous recyclable materials can be recycled for a fee:
  - tires (18" and under-no rims) Fees (all customers) \$7.00 each;
  - toilets Fees (all customers) \$6.00 each; and
  - small computer and household electronics (1 to 49 pounds, including printers, keyboards and mice) Fees (all customers) \$0.25 per pound

### CITY OF SAN DIEGO | ABANDONED VEHICLE ABATEMENT

https://www.sandiego.gov/police/services/units/traffic/abandonedvehicle

The City reported that it will be increasing efforts to deal with reported abandoned vehicles in a timely manner (6 days) instead of the current 45-60 day time period. The goal is to respond within 3 days, cite the car, and then tow the car 3 days later if it has not been moved or removed. Abandoned vehicle complaints, estimated at 4,500 per month, represent the highest number of complaints received by the City via the Get-It-Done app and telephone calls.

The City Abandoned Vehicle Abatement Unit is responsible for the removal of wrecked, dismantled and inoperative vehicles on both public and private property.

In the City of San Diego, it is illegal to leave an operable or inoperable vehicle parked for more than 72 consecutive hours without being driven at least 1/10th of a mile on a public street. It is also illegal to park any abandoned, wrecked, dismantled or inoperable vehicle on private property in public view. ### Colima St. stop sign discussion at La Jolla Traffic & Transportation Meeting 1/19/22

Installation of two stop signs on Colima St. at the intersection with Waverly St. was discussed at the January 19 meeting of the La Jolla Traffic and Transportation Board.

The intersection is near the pedestrian entrance for Bird Rock Elementary School and the Waverly gate entrance to the Bird Rock Joint Use Park. A four-way stop was suggested as a way to enhance safety for students and park visitors. There will be further outreach and discussion.

## San Diego City New Food & Yard Waste Rules

resulting from California Senate Bill 1383 https://www.sandiego.gov/environmental-services/recycling/sb1383

California Senate Bill 1383 (SB 1383) requires the reduction of organic waste disposed of in landfills. Almost six years after the passage of SB 1383 in 2016, implementation of the law became effective on January 1, 2022. Jurisdictions (i.e. cities, counties, etc.) are required to provide organic waste collection services to all residences and businesses. California residents and businesses are required to sort organic, compostable waste and dispose of the organic waste separately from recycled and other trash.

Organic waste is defined as food, food scraps and food-soiled paper from kitchens and food operations; yard, gardening, landscape, and pruning waste; organic textiles and carpets; non-hazardous wood waste including lumber and wood; paper products, printing, and writing paper; and manure, biosolids, digestate, and sludges.

The program will take effect in phases determined by residential and business location and local implementation time lines. Fines for non-compliance are scheduled to begin being issued in 2024. See the CalRecycle website at https://www.calrecycle.ca.gov/organics/slcp/collection.

The City's website states that "Senate Bill 1383 will require extensive procedural changes and significant coordination amongst different stakeholders. The City of San Diego is in the process of developing collection operations, adopting purchasing policies, amending the City's Municipal Recycling Code, enacting building requirements, preparing enforcement responsibilities and strategizing public education and outreach efforts.

As a result of this enormous planning effort, changes to yard waste collection for City of San Diego serviced residences will not begin until the summer of 2022."

The City plans to increase collection of green/organic waste to a weekly schedule in the future.

## AB 1276, Single-use Foodware Accessories and Standard Condiments

Assembly Bill 1276, signed into law on 10/5/2021, amends the law to prohibit food facilities from providing any single-us foodware accessory (such as a plastic fork) or standard condiment (such as a ketsup packet) unless requested by the customer.

The measure applies to packages for condiments like ketchup and mustard, as well as utensils like chopsticks, knives, forks and spoons. It expands on an existing state law that allows restaurants to distribute single-use plastic straws only upon request.

Businesses must be in compliance by June 1, 2022. The goal is to reduce unwanted waste and reduce business costs.



# Prevent Mosquito Breeding by Dumping Standing Water!

Mosquitoes need standing water in order to complete their lifecycle. They lay their eggs in still water and can go from egg to biting adult in as little as 5 days! This is why it is important to check regularly for standing water in and around our homes and to dump out or treat any water we find.

Mosquitoes lay their eggs in standing water. Some mosquitoes can lay their eggs in as little as 1/4" of water and can lay hundreds of eggs at a time—so even very small sources can become a big problem.





The eggs then hatch into larvae and which live in the water. These larvae look like small worms. Dump water immediately if you see larvae.

Adult mosquitoes emerge from the water and start biting. Mosquito bites can leave painful welts and some mosquitoes can spread diseases caused by the West Nile, Zika, dengue, and yellow fever viruses.



Reminder: Water Utility Rate Changes Effective Jan. 1, 2022 Dear Customer,

For the first time in 10 years, wastewater rates will increase in January 2022. In addition, a passthrough charge from the San Diego County Water Authority of 3% to pay for increases in the cost of imported water supplies goes into effect in January 2022.

The rate adjustment will increase revenue 5% for wastewater services and will help the City continue to upgrade core infrastructure by replacing aging pipes and wastewater mains. It also will fund investments like Pure Water, a landmark water recycling project that will increase the supply of local drinking water, avoid wastewater treatment cost increases and reduce discharges to the ocean.

The change to your bill will vary based on your type of account (commercial, residential, etc.) and your use of the wastewater system. For more information, please visit www.sandiego.gov/rate-increases.
