PRESIDENT'S COLUMN

I was out of the country on September 11th and unable to participate in the Bird Rock cleanup effort on that National Day of Service and Remembrance. In anticipation of the day, though, I was able to find time before our departure to pick up litter on some streets nearby our home.

In past years, I have usually found myself contemplative on September 11th. I am comfortable with my own thoughts and remembrances, without a need to be with a larger crowd in commemoration. The memories of that day in 2001 are still raw. I was fortunate not to lose anyone close to me in New York, Washington or Pennsylvania, but I was then, and remain, deeply affected by the individual tragedies. I visited ground zero with my daughter only two weeks after the attack. The gaping hole where the twin towers of the World Trade Center had stood, the cloaking ash and dust and, particularly, the cloying stench were jarring. I use those thoughts as reminders of a need for vigilance and the benefits of community service.

BIRD ROCK MAINTENANCE ASSESSMENT DISTRICT (MAD)

The Annual Bird Rock Maintenance Assessment District (MAD) meeting for assessed property owners in the Bird Rock MAD District will be held on Tuesday, November 1, 2022, from 6:15 pm to 7 pm for the annual MAD update and for review and acceptance of the proposed Fiscal Year 2024 (FY24) MAD budget that runs from July 1, 2023, through June 30, 2024. This allows adequate time for review, input, and revision of the proposed budget before final submission to the MAD Division of the San Diego City Park and Recreation Department by the mid-January budget submission deadline.

Short-Term Residential Occupancy (STRO)

City of San Diego, Office of the City Treasurer (updated 9/2/2022)

The webpage includes information about the STRO Implementation Timeline, Application Process, and Frequently Asked Questions (FAQ).

The following are important dates:

- October 3, 2022 - STRO License Application opens for all tiers (#1-4).
- November 30, 2022 - The application period for Tier #3 and Tier #4 closes.
- December 16, 2022 - The lottery is conducted for Tier #3 and Tier #4 and the host is notified.
- January 6, 2023 - License Fees are due for Tier #3 and Tier #4. Hosts selected in the lottery who do not pay the fee by 1/6/2023 lose their lottery status, and the STRO license application is cancelled.
- May 1, 2023 - The STRO Ordinance is implemented.


“The STRO Ordinance requires a license for all Short-Term Residency Occupancy (STRO) of a dwelling unit, or part thereof, for less than one month within the City of San Diego.” There are four (4) license types with varying requirements on the number of days and type of dwelling available for the STRO. A host may hold only one license and may not operate more than one dwelling unit for STRO at a time; licenses are not transferrable between ownership or location/dwelling unit.

The City website lists the following four STRO license tiers:


Tier 1 Part-Time	Tier 2 Home Sharing	Tier 3 Whole Home (excluding Mission Beach)	Tier 4 Mission Beach Whole Home
Rented for an aggregate of 20 days or less per year The owner or permanent resident does not need to reside onsite during the STRO	Renting a room or rooms in the home for more than 20 days per year so long as the owner or permanent resident resides onsite The owner or permanent resident may be absent from the permanent residence during the STRO for up to 90 days per calendar year Home sharing includes duplex properties and eligible accessory dwelling units when the host resides onsite	Rentals for more than 20 days per year where the owner or permanent resident does not reside onsite. To determine your dwelling unit's Community Planning Area (CPA), reference the City of San Diego Community Plans Map . If your dwelling unit is within the Mission Beach CPA, you would fall into Tier 4 Mission Beach Whole Home. Any other CPA would fall into Tier 3 Whole Home (excluding Mission Beach).

California regulators approve phaseout of new gas-powered lawn mowers, leaf blowers, and other small off-road engines (SORE)

AB 1349, the bill banning the sale of new gas-powered small off-road engines (SORE) and machines powered by them, was introduced in March 2021 by Assemblyman Marc Berman (D-Menlo Park) and Assemblywoman Lorena Gonzalez (D-San Diego) and approved by the California assembly and Governor. The new law directed the California Air Resources Board (CARB) to draft cost-effective and technologically-feasible regulations governing these types of gas-powered engines and tools by July 1, 2022, so that the state, counties, and cities can adopt them. Ban of the sale of new tools containing gas-powered small offroad engines, rated at or below 25 hp (19 kW), would commence by the beginning of 2024.

On December 9, 2021, the California Air Resources Board “approved a measure that will require most newly manufactured small off-road engines such as those found in leaf blowers, lawn mowers and other equipment be zero emission starting in 2024. Portable generators, including those in recreational vehicles, would be required to meet more stringent standards in 2024 and meet zero-emission standards starting in 2028.”

Two major types of new equipment that will be banned under the new legislation are gas-powered lawn mowers and leaf blowers, which contain small, highly-polluting engines. Fortunately, battery technology is evolving fairly rapidly.

According to the CARB, “Californians can continue to operate their current CARB-compliant gasoline-powered SORE equipment; there will be no ‘ban’ on using older models or used equipment purchased in the future. Older models on store shelves can also be purchased even if they are gasoline-powered.”

Reduced noise levels are a major benefit of electric motors which should positively impact many residential areas. Battery-powered systems have quieter operation, meaning equipment can run at any time, allowing more jobs to get done in areas where noise ordinances exist. Reduction or removal of gas engine exhaust, evaporative emissions, and particulates is another benefit.

The California Air Resources Board estimates that “the volume of smog-forming emissions from this type of equipment has surpassed emissions from light-duty passenger cars and is projected to be nearly twice those of passenger cars by 2031. Today, a commercial operator using one backpack leaf blower for one hour generates the same smog-forming emissions as a car driving 1100 miles. These regulations will reduce emissions of smog-forming emissions by 72 tons per day.” For further information, see: <https://ww2.arb.ca.gov/news/carb-approves-updated-regulations-requiring-most-new-small-road-engines-be-zero-emission-2024>.

Where to Recycle Batteries

All types of batteries are considered hazardous waste in California. Batteries may contain metals including cadmium, lead, lithium, mercury, nickel, silver and zinc. According to state law, batteries and other types of universal waste must be handled properly and are **not allowed** to be disposed of at the solid waste landfill.



Recycling Events

The City of San Diego offers eight (8) one-day battery and bulb collection events in the spring and fall as a convenient way to dispose of hazardous materials and prevent them from ending up in the Miramar Landfill. Items accepted at these events include oil, antifreeze, oil filters, car batteries, household batteries and fluorescent bulbs.

If you have other Household Hazardous Waste (HHW) to dispose of, please check the City's HHW webpage, <https://www.sandiego.gov/environmental-services/ep/hazardous>, for information on proper disposal options.

Recycling events are funded by the Environmental Services and Public Utilities Departments and a grant from the State of California Department of Resources, Recycling and Recovery (CalRecycle).

5 Tips for Safe and Easy Battery Recycling

1. **Safety first!** Be sure to safely prep your batteries. There are two options: bag or tape. Option A: Bag each battery in its own clear plastic bag before placing it in a storage container. Option B: you can tape the terminals with clear packing, non-conductive electrical or duct tape, keeping label visible.
2. **Stay cool.** Store the batteries in a cool, dry place. Incidents can occur when batteries (or the devices they power such as a cellphone or tablet) are exposed to inclement or excessively hot weather. Store them in a plastic [or glass] container; avoid metal.
3. **Possible damage?** If you see a swollen or bulging battery, immediately put it in a non-flammable material such as sand or kitty litter in a cool, dry place. **DO NOT THROW AWAY.** Contact **Call2Recycle customer service at 1-877-723-1297**, the manufacturer or retailer immediately for instructions, especially if the label says it is Lithium or Lithium-Ion.
4. **Timing is everything.** Aim to drop batteries to recycle within six months, ensuring they are bagged or taped. You can use our [locator](#) to find the nearest drop-off site.
5. **Spread the word.** As we all use batteries to power our world, share the knowledge about battery recycling. It's the right thing to do and helps keep batteries out of landfills!



BIRD ROCK COMMUNITY MEETING, SEPTEMBER 6, 2022

Bird Rock Community Council Board Vice President Joe Parker called the meeting to order at 6:02 pm, welcomed attendees, and introduced BRCC Board members.

San Diego Council District 1 Councilmember Joe LaCava

Councilmember LaCava noted the Stage 3 Power Alert. The California Coastal Commission (CCC) decided not to weigh in on the City of San Diego Vending Ordinance, meaning that the City can enact the ordinance in the coastal area once it has been amended to not require CCC approval. The Park and Recreation Dept. is hiring additional park rangers to enforce the code.

Mr. LaCava expressed frustration with the Development Service Department (DSD) regarding the encroachment of the restaurant at 5680 La Jolla Blvd into the public right of way and loss of a portion of the Maintenance Assessment District (MAD) landscape area with resulting removal of landscaping and permeable ground area and replacement of landscaped areas with concrete. He noted that this was the second time that DSD had allowed a developer to step into a MAD area (first time in Torrey Hills), and that he planned to take action to prevent future occurrences.

Mr. LaCava discussed 1) the Capital Improvement Plan (CIP) joint request list from the La Jolla Community Planning Association, 2) clarifying language proposed for the Municipal Code regarding beach fires, 3) the update regarding Community Planning Groups and conformance with the City Charter, and 4) the impending selection of a preferred developer for the Sports Arena site. He provided a further explanation of Mayor Gloria's "Build Better" program and Development Impact Fees (DIF).

Joe Parker asked about a locally-proposed ban on gas-powered landscape maintenance blowers.

San Diego Humane Society: Julianna Tetlow, Director of Government Relations, and Danee Cook, Humane Law Enforcement Captain of Operations

Juliana Tetlow and Danee Cook gave a presentation about San Diego Humane Society (SDHS), a private non-profit organization, a national leader in animal welfare. SDHS has a 5-year contract, expiring 6/30/23, with the City of San Diego to provide services including animal control, lost and found, licensing, and humane law enforcement. SDHS provides animal shelter, animal care and veterinary services, field and dispatch services, adoptions, behavior training, and more to 14 cities including San Diego. The San Diego campus is located at 5500 Gaines St., San Diego 92110, with main hours from 10 am – 6 pm Tues.-Sun. (ph 619-299-7012). SDHS cares for more than 40,000 animals annually.

For off-leash violations, residents can call 619-299-7012, ext. 1, to reach dispatch or email investigations@sdhumane.org. An available officer will be dispatched when officers are not handling urgent calls involving animal cruelty, injury, or imminent danger to animals or people. Some violations may not be witnessed by a responding officer, however SDHS does conduct park specific patrols and has information recorded in their dispatch system to help prioritize parks with on-going issues and identify problematic times of day or days of the week. Note that the SDHS does not handle barking dogs which is the responsibility of San Diego City Code Enforcement.



Updates from Bird Rock Committees and Working Groups

Don Schmidt from the Ad Hoc Bird Rock Coastal Overlooks Committee had no update. Craig Bender, Bird Rock Merchants Group, reported that Halloween Merchant Window Painting will be Sat. October 22. Arianna Opsvig, (Vision Bird Rock) noted that the Birdstock neighborhood event is postponed to next year.

Bike Path Enhancement and Beautification Plan

Trace Wilson discussed ideas for improving, re-naturalizing, enhancing, and beautifying the Faye Avenue Extension Bike Path from Nautilus to Via del Norte and from Via del Norte to Camino de la Costa. Varied ownership and oversight of the bike path include the City Streets Division, Park and Recreation Dept., and Real Estate Assets and private entities. He thanked Debbie Adams for long-term efforts towards bike path clean up projects. Trace presented ideas including resurfacing the path, enhancing ADA compliance, adding native plants and shade-producing trees, creating hiking paths, as well as adding post and chain railings where needed. There is a lot of support for the project which would be relatively easy to accomplish with potential funding from county and state agencies. With increased usage and oversight, it should be easier to maintain the path and avoid or mitigate various problems that have plagued the area.

Safer La Jolla Boulevard Speed Limit Reduction Petition

Bird Rock resident Harry Bubbins noted that La Jolla Blvd from Loring St. to south of the Colima St. roundabout is 35 MPH. It drops to 15 MPH in the roundabouts and is 25 MPH between roundabouts. He believes the speed limit on La Jolla Blvd between Loring St. and the Colima St. roundabout is too high and that a slower speed limit would save lives, prevent injuries, and reduce the drive-overs and traffic accidents at the Colima roundabout. Bird Rock Maintenance Assessment District (MAD) Update

At the 3rd Quarter City July 28 inspection of the Bird Rock MAD, the MAD received an excellent report. Trees and tree wells throughout the MAD were inspected. Tree wells were filled with large river rocks as a best management practice to reduce trip hazards. Frequent tree trimming maintains adequate pedestrian clearance and safe distance between branches and adjacent buildings for fire code and vector control.

Excessive speed and distracted driving along La Jolla Blvd have resulted in drive overs/hit-and runs with MAD landscaping, irrigation, and guard railing damage. All damage is checked and repaired.

Vandalism and code compliance issues have been noted. Problematic, illegally placed signs are removed from within MAD areas and from City street signs, crossing signals, and utility poles and boxes, as required by the MAD contract. Missing and damaged street signs continue to be reported to the City.

Public Comment

Faulty pedestrian crossing signals are reported. A future capital improvement project would be to upgrade or replace pedestrian crossing signal lights and hard-to-see, non-functional in-road crossing lights in Bird Rock with the higher intensity, horizontal, pole mounted, rapid flashing, solar powered beacon lights.

La Jolla Capital Improvement Plan (CIP) requests for FY23/24 were endorsed by La Jolla Community Planning Association, La Jolla Shores Association, La Jolla Parks & Beaches, and BRCC for submission to Council District 1 and included high priority, much-needed CIPs for City FY 23/24 budget consideration. The resulting list included 7 high priority items including the repair and restoration of La Jolla Hermosa Park in Bird Rock. The list and brief cover letter were sent to Councilmember Joe LaCava with copies to Mayor Todd Gloria and the 8 other Council District members.

This priority list has been effective in the past and resulted in City-approved funding for the City Traffic and Storm Water project that has solved the 2+ decades flooding problem at La Jolla Blvd and Forward St.

Fundraising is underway for D. Richardson's Eagle Scout project to replace 2 dilapidated Calumet Park benches. A donation form can be found in the Bird Rock Newsletter. Dedication plaques will be moved.

Bird Rock Maintenance Assessment District (MAD) Annual Meeting Tuesday, 11/1/21, 6:00 pm

The annual meeting for assessed property owners in the Bird Rock Maintenance Assessment District (MAD) will be held on Tuesday November 1, 2022, for updates and review and acceptance of the proposed Fiscal Year 2024 (FY24) annual MAD budget (July 1, 2023, through June 30, 2024). The November 1, 2022, meeting allows time for adequate review, input, and revision of the proposed budget before final submission to the MAD Division of the San Diego City Park and Recreation Department by the mid-January deadline. Following further evaluation and finalization, the MAD budget is submitted to and included in the City's annual budget review process which starts on or before February 1 and concludes with the June 2022 budget approval by the Mayor and City Council.

The background leading to the Bird Rock MAD formation is important. Prior to formation of the MAD and re-design of La Jolla Blvd in the Bird Rock area, La Jolla Blvd was 4-5 lanes across with very high-speed traffic and considerable safety issues. After decades of concerns about traffic speed, injuries and fatalities, and safety along La Jolla Blvd and the realization that La Jolla Blvd was a dangerous, fast-moving divider between the east and west portions of the Bird Rock neighborhood, discussions began in year 2000 about neighborhood "traffic calming." Topics included vehicular speed reduction, traffic management, parking issues, pedestrian and vehicular safety, neighborhood "walkability," quality of life, and lighting. The dialogs included ways to implement traffic calming, improve safety for pedestrians crossing La Jolla Blvd (4-5 lanes), enhance beautification, add landscaping and trees, and improve parking in the Bird Rock business district along La Jolla Blvd. without adversely impacting adjacent streets and residential areas. Many Bird Rock neighbors participated and spent numerous hours in research and discussions that resulted in an enormous improvement to Bird Rock. We are grateful to all those people.

In 2004, Bird Rock property owners and the Bird Rock Community Council (BRCC) initiated formation of the Bird Rock Maintenance Assessment District for the purpose of assuming responsibility for maintenance of the public landscaping portion of the City-planned, traffic-calming improvements along La Jolla Blvd and nearby residential streets with the intent of becoming a self-managed MAD (versus City-managed). Self-managed MADs must be managed by stable community non-profit 501(c)(3) corporations. This effort culminated in March 2005 when more than 30% of the property owners signed a petition agreeing to formation of the district. In July 2005, property owners formally voted, via a ballot from the County Registrar of Voters, to approve formation of the MAD, to appoint the non-profit 501(c)(3) Bird Rock Community Development Corporation (BRCDC) dba BRCC as local managers, and to set the initial assessment at \$90 per year per single family property. Upon the San Diego City Council's certification of ballots and approval to form the Bird Rock MAD in August 2005, the BRCC began successful negotiations with the City for a maintenance agreement and self-management of the Bird Rock MAD by BRCC.

The Bird Rock MAD encompasses the Bird Rock area bounded on the west by the Pacific Ocean; on north by La Cañada Street; on the east by Folsom Drive, Bellevue Avenue, Linda Rosa Avenue, and La Jolla Mesa Drive; and on the south by Bellevue Place, Bird Rock Elementary School/Bird Rock Joint Use Park, the Park La Jolla property, and Wrelton Drive.

The BRCC took over landscape maintenance of phase one of the traffic calming MAD area in 2008 and assumed maintenance responsibilities of phases two and three in May 2009, which encompassed the entire Bird Rock MAD area. The MAD and BRCC Board selected and contracted with 1) an independent contractor to manage day-to-day MAD operations and perform bi-weekly inspections and numerous other management tasks and 2) a City-approved, licensed landscape maintenance contractor for regular landscape and irrigation system maintenance, selected public right of way clean up and trash disposal, and additional services. Newer contracts have been approved and established with City-approved companies since the initial phase. The City reviews the Bird Rock MAD landscaping, irrigation, water usage, all City trees maintained by the Bird Rock MAD and contractual requirements as well as traffic calming, safety, line-of-sight, and maintenance issues during quarterly inspections.



The City is more focused on its Climate Action Plans lately and the required maintenance of City trees. The City has been very satisfied with the supervision, financial oversight, operations, and water saving efforts of the Bird Rock MAD. The BRCC Beautification Committee independently inspects the MAD areas and reviews the landscaping and various MAD-associated environmental, safety, maintenance, irrigation, water conservation, and aesthetic issues. Suggestions for traffic calming, safety improvements, walkability, and beautification are considered. MAD landscaping improvements were approved in 2010 and continue to be implemented to increase traffic calming and safety. Plants that created safety problems or succumbed to traffic emissions, pests, or other causes have been replaced. These ongoing efforts result in safer conditions, better adherence to line-of-sight height limits, traffic calming, reduction of drive overs, adherence to mandated water restrictions and water conservation, decreased long-term maintenance, increased visual appeal, and conformance to the original community-chosen California coastal/ Mediterranean palette.

The Capital Improvement Bird Rock Median LED Light Project on the La Jolla Blvd medians between Forward Street and Camino de la Costa was successfully completed by the City at the end of 2012. The median lights provide mid-block lighting, enhance pedestrian and vehicular safety, create a better walking environment, and improve visibility of adjacent buildings and the roadway. The City-maintained cross-walk systems, street lights, and median lights are monitored, and problems are reported to the City. Similarly, problems noted with street signs, public rights of way, graffiti, potholes, Municipal Code violations, and related issues are also reported to the City.

The BRCDC's separate MAD and BRCC financial accounts are independently audited at the end of each fiscal year. The annual, independent MAD account audit is required by the City. The audit for the recent fiscal year ending June 30 determined that the BRCDC MAD account and regular accounts are in great condition with proper operating procedures, financial controls, and operating reserves.

The Bird Rock MAD budget is funded by annual property owner county property tax assessments, gas tax funds from the City, and offsetting payments from the City for services provided by the MAD which should have been provided by the City (General Benefit Offsets). Currently, there are 1320 assessment-paying property parcels within the 1476 parcel Bird Rock MAD Map Boundary for a total of 1,826.97 EBUs (Equivalent Benefit Units). 156 properties, mostly north of Camino de la Costa plus a few undeveloped parcels, do not pay a MAD assessment as part of their country property tax.

The annual residential assessment rate was \$90 in Fiscal Year 2006 (FY2006), \$50 in FY2007, \$75 in FY2008, and \$79 in FY2009 when BRCC assumed full maintenance of the MAD. The rate dropped to \$25 in FY2010 when the MAD reserve fund maximum balance was reached. For FY2011, FY2012, FY2013, and FY2014, the assessment rate was \$78. To fund increasing MAD costs, anticipated guard railing improvements, and the required reserve fund balance level, the assessment rate for FY2015 and FY2016 was increased to \$90 for residences. The rates for FY2017 and FY2018 were lowered to \$84 due a healthy reserve fund balance and was raised in FY2019 to \$95. The rate for FY2020 through FY 22 was decreased to \$90. Due to cost increases and pandemic effects, the rate for FY 2023 was raised to \$100 for residences, well below the \$214.25 maximum allowable rate. The rate for FY 24 is estimated to remain at \$100, also below the \$224.50 estimated max allowable rate. The condominium rate will be proportionally lower at \$70. The typical commercial property rate should be \$500..

As mandated by state law, the reserve fund balance (excess funds) accumulate in a City-controlled, interest-bearing account. Those funds are reserved and protected for the Bird Rock MAD. The Bird Rock MAD is required by the City to maintain a reserve operating balance between 10% and 50% of annual operating expenses and maintains an emergency reserve as well.

The annual meeting is an opportunity for Bird Rock property owners to review the budget for the next fiscal year, ask questions, and offer comments. Your participation is welcome.
