# 2. Bird Rock Neighborhood Watch and SDPD

Michelle Fulks, who manages our Neighborhood Watch and Jessica Thrift, who is the SDPD Community Relations Officer for the Northern District, are with us tonight to discuss issues of interest to Bird Rock.

Michelle and Officer Jessica Thrift provided the following info, some of which was in response to questions from Bird Rockers at the meeting.

- Keeping lights on in businesses and at home is a good way to decrease crime.
- With adequate lighting at night, police officers can see what is going on and react to suspicious activity.
- At your homes and businesses use cameras and alarms and make sure they are turned on even when you are away briefly.
- Let your neighbors know when you will be away and ask them to keep an eye out.

- Use the City's Get-It-Done website or app to report streetlights that are out or other things that need City attention.
- To decrease bike thefts and/or increase the chance of having a stolen bike returned, use
  a strong lock, etch your name or other identifier on the bike, and record the serial
  number of the bike in a place you will remember.
- Apple AirTags can help locate stolen property, but the police cannot enter a home or business without a search warrant, which are difficult to obtain using AirTag info alone.
- The SDPD is trying to address the e-bike problems, in part with grant funds to help with enforcement.
- There may soon be a law that prohibits anyone less than 12 years of age from operating an e-bike.

This was a homecoming experience for Andres, who had attended BRE. He encouraged Bird Rockers to contact him if they need help with state agencies or have other issues their office can help with.

Mariah and Andres focused on AB-2234: E-Bike Safety Training, which would provide a bike safety handbook with the rules of the road. It is pending referral to the Senate. They are trying to establish a pilot program in San Diego County that would prohibit anyone less than 12 years of age from operating an e-bike. Unfortunately, with respect to e-bikes, California is part of the Wild West with few restrictions on who can operate an e-bike, the max speed of an e-bike and where they can be operated. There are no licensing requirements for an e-bike or an operator of an e-bike. If the law is changed to prohibit children less than 12 from operating an e-bike, it has not been determined if the child or the child's parent/guardian would be penalized for a violation. Bird Rockers at the meeting voiced concern about the lack of restrictions and the related traffic safety issues.


We would like to identify a preferred option, solicit cost proposals for that option and submit that option to the City for approval.



# What do you think and what are your questions about tree lighting?

The responses from primarily non-Board members, Bird Rockers at the meeting were as follows.

- A few spoke in favor of up lighting.
- One spoke in favor of down lighting.
- None spoke in favor of tree wrap lighting.
- In a hand vote, all in the audience favored flush up lighting.

The latest tree wrap example may have been part of the problem. But some opposed such lighting for other reasons (e.g., it looks too much like Del Mar or even worse like Disneyland, it will make it more difficult and expensive to care for the trees, and it will hurt the trees and contribute to global warming and, therefore, to the end of Bird Rock and civilization as we know them). I took some poetic license for the last example.

The BRCC Board will decide the next steps for finalizing the specifics of the lighting project and will keep Bird Rockers informed with emails from <a href="mailto:info@birdrockcc.org">info@birdrockcc.org</a>, info in the Bird Rock Newsletter, info posted at birdrockcc.org, discussions at regularly scheduled BRCC Community Meetings, and, if necessary, with a special BRCC Community Meeting.

# b. Bird Rock Signage/Monument Project

As noted in a May 29 email to those on the BRCC email list, seven BRCC Board members had an onsite discussion of the siting options for signage (i.e., a rock etc.) in or near the Colima and Camino de la Costa roundabouts. A mock rock that we placed at several sites was a very useful visual aid for that discussion. Although they had different opinions about the best site before

that discussion, those seven Board members agreed that the tentatively preferred sites are in the median about 6 to 12 feet past the first MAD crosswalk as you enter Bird Rock from the north or south.





Potential advantages of the tentatively preferred bookend sites for the rock etc.

- 1. A rock etc. at those sites would not block the line of sight or be a distraction for drivers in the roundabouts.
- 2. A rock etc. at those sites would not block the drivers' views of pedestrians as the drivers approach those cross walks at a higher speed as they enter Bird Rock.
- 3. A rock etc. at those sites would not compete with the roundabouts or be diminished by being in a roundabout. This is a point Matt Sheredy of Integrated Sign Associates also made the previous week.

- 4. Unlike the roundabouts, these sites in the median do not have traffic signs that would distract from the rock etc.
- 5. People would be able to admire, take pictures of and otherwise enjoy the rock etc. from the safety of the part of the crosswalk in the median.
- 6. Gary Pence, Senior Traffic Engineer, said that a monument in the median presents significantly less of a concern since there is not an oncoming traffic issue.
- 7. The approvable total height of the rock with pelicans on it is probably greater in the median.
- 8. A rock etc. at those sites would not block view to the ocean from either La Jolla Blvd or the cross streets.
- 9. Reckless drivers are less likely to damage a rock etc. at those sites.
- 10. They are Bird Rock bookend sites, which most seem to prefer to a single monument in the median of the 5600 block of La Jolla Blvd.

At its meeting last week, the BRCC Board voted to solicit cost proposals for the following:

- 1. Two large rocks (one at each of the sites mentioned above);
- 2. One larger rock in the median at about the middle of the 5600 block of La Jolla Blvd;
- 3. Bird Rock etched into each rock; and
- 4. A few pelicans on each rock.

The traffic clearance requirements identified by City traffic engineers will influence the size of the rocks. The inclusion of the mid-block third rock in the cost proposal does not indicate that the Board has approved it as part of the project. A preliminary cost estimate for the two large rocks is about \$10,500, excluding the cost of pelicans and permits. We do not have a preliminary cost estimate for the one larger rock. Depending on what permitting process is required, permitting could take more than a year. An extremely generous \$25,000 donation from Dennis Bender, a Bird Rock resident, has helped ensure we will have adequate funding for this project.

This project has been well publicized at BRCC Community Meetings, in emails from info@birdrockcc.org, in articles in the Bird Rock Newsletter, and in articles by the La Jolla press corps.

We just need to sort out the final details so we can request cost proposals and start the approval process.

#### What do you think and what are your questions?

One Bird rocker suggested the BRE rock (see photo above) is a good example of what we should do.

The votes mainly from non-Board, Bird Rockers were as follows:

- 5 for bookend rocks etc.;
- 1 for the third rock (i.e., a rock etc. in the median near the middle of the 5600-block);
- 2 for all three rocks; and
- 2 for no rocks.

There were questions about whether we would consider multiple design options for the rocks etc. and whether the BRCC members would be asked to vote on the final design. The answers were as follows.

Trace Wilson provided the examples shown on the big screen, we expect he will finalize his renderings after we get rock etc. dimension limits from the City traffic engineers and, because we will use natural rocks, the rocks that would actually be used will depend on what we can find at a local store for very large rocks. We hope that the rocks we use would loosely reflect the color of the real "Bird Rock" rock The Board plans to move forward to develop a well-defined project without additional rounds of alternatives, while keeping Bird Rock informed as it does that.

With respect to a vote by Bird Rockers on the final design, I said the BRCC is an example of representative government and that the Board, as the elected representatives of the BRCC, not the membership or some other group, will make the final decision on what to submit to the City for approval.

Update from the Office of Congressman Scott Peters Bird Rock Community Council, 06/04/2024

# **Updates from Washington, D.C.**

- In early May, Rep. Peters led a bipartisan request with Rep. Escobar (TX-16) and 8 of their colleagues for \$278 million for the International Boundary and Water Commission's (IBWC) construction budget in the Fiscal Year 2025 (FY 25) Appropriations bill. This represents a \$200 million increase over the President's request and is in addition to the \$156 million Rep. Peters already secured in the FY 24 appropriations bill. The IBWC is the federal agency tasked with operating and maintaining the South Bay International Wastewater Treatment Plant (SBIWTP), which has fallen into disrepair and is at the center of the cross-border sewage crisis on the American side of the border.
  - o The members also requested language to allow other federal agencies and non-federal entities, such as state and local governments and non-profit organizations, to transfer money to the IBWC and \$89.3 million for the IBWC's Salaries and Expenses account, which is a \$20 million increase over the President's request. The total funding request, if enacted, would be enough for IBWC to fix and upgrade SBIWTP to treat 50 million gallons of wastewater per day. This will

- significantly reduce the amount of pollution reaching San Diego beaches, and in combination with actions taken by Mexico, will decrease the number of days beaches are closed and the toxic fumes that people in San Diego, Imperial Beach, and elsewhere breathe.
- o At a mid-May House Energy & Commerce Subcommittee Hearing on the Fiscal Year EPA Budget, EPA Administrator Michael Regan thanked Rep. Peters for securing the \$156 million in FY24 funding for the South Bay Water Treatment Plan. He also confirmed that they are prepared to provide the remaining \$290 million in funding for the expansion needed, stating that this past January, the EPA and IBWC finalized an Interagency Agreement to transfer the USMCA funds to the IBWC for treatment expansion projects. The \$290 million referred to is what is remaining from the funds secured from the USMCA in 2020, which will be used to fund a portion of the contract, which IBWC says they plan to execute this summer.
- In Mid-May, Rep. Peters <u>voted to pass the FAA Reauthorization Act of 2024</u> to maintain American leadership in aviation safety and aerospace innovation, help fund improvements at airports nationwide, strengthen and diversify the U.S. aviation workforce, make groundbreaking investments in sustainability and climate resiliency, and improve consumer protections and accessibility for travelers with disabilities.
  - o "Thanks to this bipartisan legislation, passengers can look forward to more convenient airport terminals, reduced airport noise levels, the ability to sit next to young family members at no additional cost, and long-term investments in our nation's aviation workforce," said Rep. Peters. "I look forward to the President signing this bill into law to create good-paying aviation jobs in San Diego, ensure aviation safety, and enhance the passenger experience for travelers across the country."
    - o Of significance to San Diego, the FAA Reauthorization Act of 2024 includes:
  - o \$4 billion for the Airport Improvement Program (AIP) to fund critical airport projects around the country, including a portion to San Diego International Airport's new Terminal 1.
  - o \$350 million to replace cancer-causing PFAS-containing firefighting foam at airports, including at San Diego International Airport.
  - o Immediate cash refunds for travelers on flights that are canceled or significantly delayed, even with non-refundable tickets.
  - o At least \$150 million annually in AIP funds to reduce noise and carbon emissions and improve climate resiliency.
  - o Strengthens the FAA's Community Collaboration Program by streamlining the process to update noise standards, which must include input from airports, flyers, local community groups, and individuals living near airports.

#### **Updates from San Diego**

 Congressman Peters recently had a productive District Work Period in San Diego this past month, including the following:

- o For Endangered Species Day, Congressman Peters and our staff visited the Rhino Rescue Center and the Frozen Zoo, learning more about the San Diego Zoo Wildlife Alliance's conservation efforts.
  - o Congressman Peters met with a 103-year-old WWII veteran ahead of his visit to Normandy with other veterans to commemorate the 80<sup>th</sup> anniversary of D-Day. o Congressman Peters attended the annual Fiesta de los Peñasquitos and Escondido Spring Street Festival, talking to constituents and community groups, including the Vietnam Veterans Association.
- o Congressman Peters met with the Downtown San Diego Partnership and visited the O Lot Safe Sleeping Site, learning more about their work on addressing homelessness in San Diego and hearing what support they need.
- o Congressman Peters attended multiple ceremonies commemorating Memorial Day in San Diego.
- o Congressman Peters participated in a press conference with the U.S. Coast Guard as they announced having seized over 33,000 pounds of illegal narcotics in international waters from seven suspected drug smuggling vessel interdictions/events from February and March, highlighting the importance of interagency cooperation to combating transnational criminal organizations and the illicit drug market.
- o Congressmembers Peters and Jacobs held a press conference on Friday, May 31<sup>st</sup> highlighting funding wins for San Diego military bases and families included in this fiscal year's spending bills. This includes significant allocations that will help military families, bolster on-base medical services, increase childcare options, and bring jobs to the region.
- o On Saturday, June 1, Congressman Peters spoke at the monthly meeting of the San Diegans for Gun Violence Prevention, focusing on National Gun Violence Awareness
- Month and highlighting bills that he has cosponsored in the U.S. House of Representatives to address gun violence.
- o Congressman Peters and our staff also met with numerous constituents, community groups, and businesses.

#### Congressional Art Competition

o Our office held a reception on Tuesday, May 28<sup>th</sup> at the San Diego History Center in Balboa Park for high students who participated in our Congressional Art Competition. The History Center will continue to host an exhibit with all the submitted artwork through the summer. The winner as chosen by our panel of community judges will continue to have their artwork proudly displayed in our nation's Capitol for one year. o More details can be found at

#### Congressional App Competition

o The Congressional App Challenge officially launched on May  $1^{st}$ . Students are now eligible to register and may start submitting their full applications. Applications will close on **October 24, 2024**, at 9:00 AM Pacific Time.

- o The competition is open to students who reside or attend school in California's 50th Congressional District and who will be enrolled in middle or high school in the fall of 2024. Students may compete in teams of up to four. Individuals submitting on behalf of teams must meet the eligibility requirements for individual contestants.
- o A winner will be announced in early December 2024. Every spring, winning individuals or teams are invited to Capitol Hill where they demo their apps to their Representatives at a celebration called #HouseOfCode. It's the most prestigious demo day in student STEM the new national science fair. At #HouseOfCode students get to see their apps displayed in the U.S. Capitol Building, meet their Representatives, and connect with other coders from around the country!

# Assemblymember Tasha Boerner – AD 77 June 2024 Updates

# Asm. Boerner's Bills Introduced in the 2024 Session:

1. AB-1992: Blue Carbon Projects in Coastal Developments

This bill would authorize the California Coastal Commission to add blue carbon demonstration projects to the suite of factors it considers for potential mitigation when approving coastal development permits, where feasible.

Status: Senate Committee on Natural Resources and Water

#### 2. AB-2043: Medi-Cal Transportation Reimbursement

This bill would require Medi-Cal Managed Care Plans (MCP) to ensure that the fiscal burden of nonemergency medical transportation (NEMT) or nonmedical transportation (NMT) is not unfairly placed on public paratransit service operators.

Status: Senate Committee on Health

#### 3. AB-2234: E-Bike Safety Training

This bill would authorize the County of San Diego to establish a pilot program banning e bikes for anyone under the age of 12.

Status: Pending Referral - Senate

#### 4. AB-2259: Bike Smart Handbook

This bill would direct the California State Transportation Agency (CalSTA) to develop and distribute, on or before September 1, 2025, the Bike Smart Handbook, a bicyclist and e-bike safety handbook based on evidence-based practices and emerging trends.

Status: Senate Committee on Transportation

#### 5. AB-2564: Senior and Disabled Citizens Property Tax Postponement Fund

This bill would secure a permanent funding source for the Senior Citizens and Disabled Citizens Property Tax Postponement (PTP) Program, supplementing the collections of existing PTP accounts.

Status: Pending Referral - Senate

#### 6. AB 2666 - Refunding Excess IOU Profits

This bill would direct the California Public Utilities Commission (CPUC) to require an electrical or gas corporation, if the CPUC determines that an electrical or gas corporation has received revenues from its ratepayers that are in excess of its authorized rate of return for a prior year, to refund any excess revenues from a prior year to its ratepayers.

Status: Pending Referral – Senate

#### 7. AB-2715: Ralph M. Brown Act: Closed Sessions

This bill would allow matters of cybersecurity to be discussed by a legislative body of a local agency during closed session, provided that any action taken on those matters is done in open session

<u>Status</u>: Senate Committee on Local Government

8. <u>AB-2756</u>: Preventive Postpartum Pelvic Floor & Core Conditioning Exercises · This bill would authorize a three-year pilot program in the county of San Diego for preventive pelvic floor and core conditioning group exercises within the six to twelve week postpartum window to help birthing people rebuild their pelvic floor after pregnancy.

Status: Pending Referral - Senate

# **Budget:**

- On Monday, the Mayor held a press conference at Fire Station 44 in Mira Mesa to
  discuss the importance of funding the City's public safety departments: Police, Fire, and
  Lifeguards. Keeping residents safe is his number one priority, and that is why his
  proposed budget fully funds these departments. Unlike the 2010 budget deficit the City
  experienced, where fire stations were browned out and personnel was reduced, Mayor
  Gloria continued to fund these departments and did not close any facilities or reduce
  hours.
- As a reminder, the Mayor's proposed budget also continues investments in homelessness by adding 1,000 shelter beds and doubles the safe parking program with 200 new spaces at H Barracks. It also continues to invest in road repairs and other infrastructure like sidewalks and storm drains. For example, the budget is estimated to resurface about 75 miles of streets (15 more miles than the previous fiscal year) and invest \$85 million in funds for stormwater/flood-resilience/green infrastructure projects. This proposed budget also maintains all neighborhood services like parks and libraries and their programs with no reduction in hours or programs.
- The next key dates for the budget hearings where the public can provide comments on their priorities are **Friday June 7th at 9 am and June 11th at 2 pm.**

#### **Police Chief Nisleit Retires:**

- After 36 years of service with the San Diego Police Department, Chief Nisleit, will be heading into retirement this week. Mayor Gloria joined CM von Wilpert in presenting the Chief with a proclamation and hosting a special ceremony with the City Council. Mayor Gloria is extremely grateful to Chief Nisleit, his dedication, and leadership of the Police Department – which resulted in San Diego being one of the safest big cities of the country.
